**I. Call to order**

Gary Boggs called the meeting to order at 7:04pm.

**II. Roll call**

**III. Minutes from last meeting**

The minutes were read for the last meeting. H.A. Merricks made a motion to accept the minutes as read; 2<sup>nd</sup> by Glenn Mitchell. Motion passed 5-0.

**IV. Open issues**

**V. New Business**

There were two (2) special use permits to discuss. The 1<sup>st</sup> was for Community Alternatives of VA dba Blue Ridge Day Options. No one from the public or from the applicant was in attendance to speak. The commission recommended the special use permit be presented to council with the following restrictions: The applicant must be duly licensed and in compliance with all state laws. Jeremy Shelton made a motion to present the special use permit to council with the stated restrictions; 2<sup>nd</sup> by Glen Mitchell. Motion passed 5-0.

The 2<sup>nd</sup> was for The Showdown, a tournament business to be located in Staunton Plaza. There was one person to speak, Ken Stone. The commission asked that the applicant re-apply with their name, their dba name, the hours of operation for each day, for the rules to be enforced as presented, to strike the word 'cash' from prizes, make reservations online, be bonded, parking lot well lighted, winnings must be paid with business check, provide own security,

no alcoholic beverages onsite, have card reader for credit card payments and no more than \$3,000 cash on hand at any one time on the application.

Jeremy Shelton made a motion to forward the special use permit to council with the items restrictions above; 2<sup>nd</sup> by H.A. Merricks. Motion passed 4-1.

No one from the public was present to speak on proposed ordinance changes to section 4-16.1 Regulations as to Keeping of Chickens in the Town, 4-6 and 4-1. Jeremy Shelton made a motion to forward the proposal ordinance changes to council for consideration; 2<sup>nd</sup> by Glen Mitchell. Passed 5-0.

No one from the public was present to speak on proposed ordinance changes to chapter 4 (4-2, 4-3, 4-131 and Article XIV). Bob Majure made a motion to forward the proposal ordinance changes to council for consideration; 2<sup>nd</sup> by Glen Mitchell. Motion passed 5-0.

No one from the public was present to speak on proposed ordinance changes to chapter 5 (5-8, 5-9, 5-17, 5-24, 5-64). In section Q, the word 'civil' was changed to 'professional'. In section 5-64 A., the word 'sad' in the 1<sup>st</sup> sentence was changed to 'said'. Jeremy Shelton made a motion to forward the proposal ordinance changes to council for consideration; 2<sup>nd</sup> by H. A. Merricks. Motion passed 5-0.
